In early 2015 a group of tourism operators collaborated to create a comprehensive plan to grow tourism in the Mount Gambier region. The strategic plan - 'Changing the tourism culture; an industry plan to grow Mount Gambier's tourism economy' - is recognised as a peak reference document for developing our tourism economy by the South Australian Tourism Commission, the City of Mount Gambier Council and Mount Gambier Chamber of Commerce. The plan complements the South Australian Government's growth targets for South Australia's tourism economy. Since April 2016 TMG has been a sub-committee of the Chamber of Commerce.

Vision Mount Gambier is recognised as a world renowned tourism destination.

Mission Tourism Mount Gambier will work with stakeholders to provide leadership to grow the tourism economy

Objectives

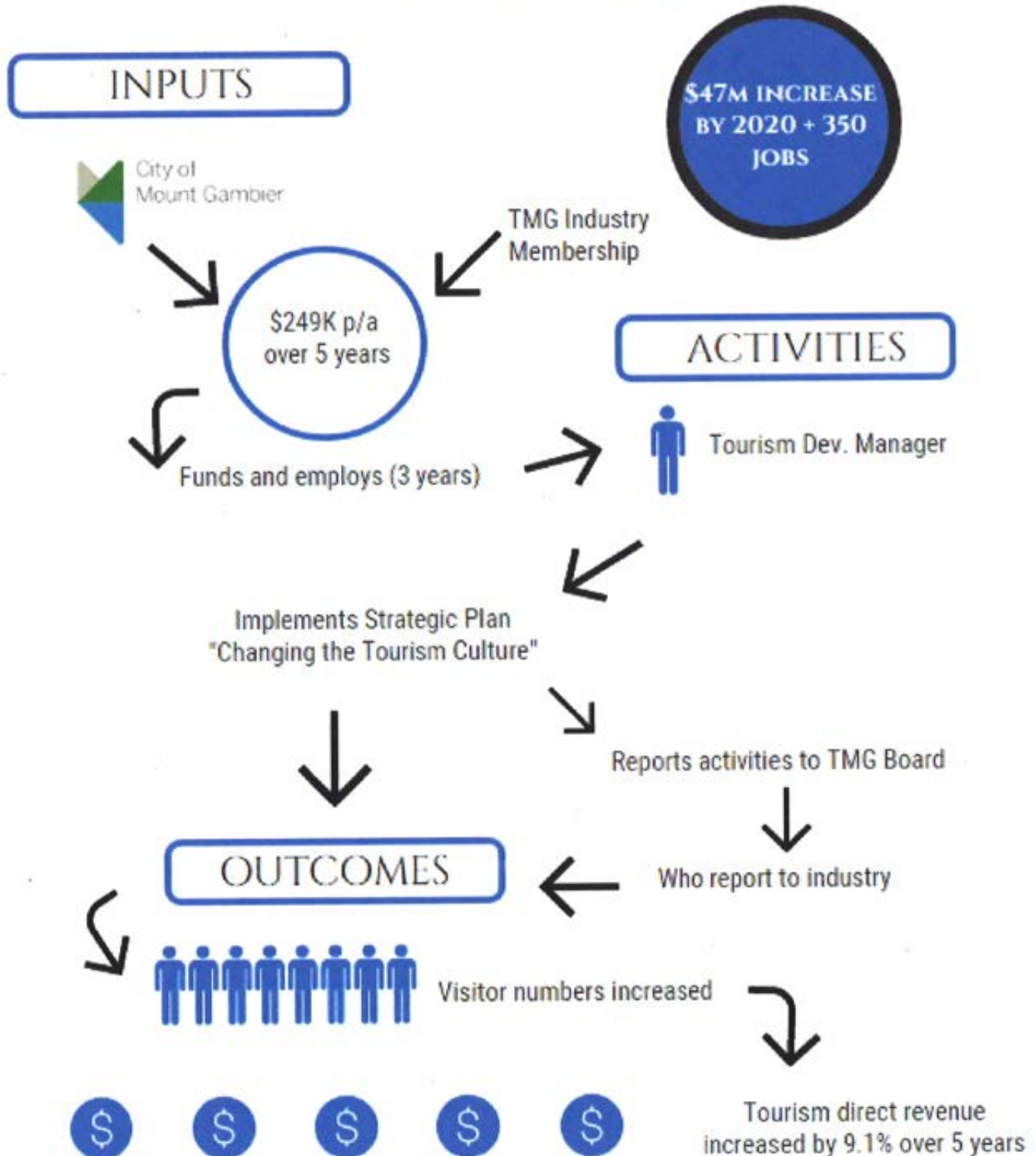
1. Increase visitation to Mount Gambier so that tourism direct revenue increases by 9.1%pa over five years
2. Provide a peak industry representative body for the tourism industry
3. Promote Mount Gambier as a tourism destination
4. Increase tourism direct revenue to Mount Gambier by promoting new tourism product and services and the expansion of existing tourism product and services.
